Nyandarua County Assembly (First Assembly, First Session) (Second Special Sitting)

OFFICIAL REPORT

(The House met at 2.30 pm)

Hon (speaker in the Chair)

Nyandarua County Appropriation Bill, 2013. (The first county assembly appropriation Bill)

Speaker: Hon. Members we have come to the second sitting of the day as earlier agreed. I now ask the clerk to read the next order.

Clerk: Committee of the whole House

Speaker: Committee of the whole House. As you are aware the proceedings of the business of committee of the whole house had been adjourned to allow for deliberations (Kamukunji) of the Appropriation Bill. I now request the chairman of the committees to take over the proceedings once again from where they had been terminated in the morning during the morning session.

Short Title: This Bill may be cited as the Appropriation Bill, 2013 was approved without amendments.

Long Title: A Bill of County Assembly to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2014 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and related purposes was passed after amendments by inserting the word 'related' between the words 'and' and 'purposes'.

Clause 2(1) : The leader of the majority Hon James Mwangi Gichuki (ENGINEER) moved a motion of amendment to delete the words Four Billion, nineteen million seven hundred and twenty four thousand two hundred and fifty three appearing between the words shillings and the word 'and'. Hon: Silvester Mwangi (GITHIORO) Seconded the motion.. The words Four

Billion, nineteen million seven hundred and twenty four thousand two hundred and fifty were deleted.

Still on the same clause, Hon Gichuki moved a motion of amendment to insert the figure 4,308,708,008.60 . He was seconded by Hon Samuel M. Thuita (GATHANJI) and clause 2(1) become part of the Bill.

Shedules 1, Services for which money is appropriated was inserted just before the recurrent expenditure and it become part of the bill.

CODES

R001: The leader of the majority Hon. James Mwangi Gichuki supported R001 to be part of the Bill but with amendment to delete figure 314,812,014 (Supply) and insert figure 263,445,709.70 in its place and was seconded by Mirangini member Hon Ndirangu. R001 as amended becomes part of this Bill.

R004: The leader of the majority moved a motion of amendment to delete figure 150,568,922 (Supply) and insert 150,568,921.90. R004 as amended becomes part of this Bill.

R007: Gathioro member moved a motion of amendment to delete figure 65,901.149 (Supply). Karau member Hon. Sammy Douglas Kamau seconded the motion. Gatimu member Hon. John Kieru wambui moved a motion of amendment to insert figure 65,901,049.20. The figure was inserted and code R007 as amended become part of the Bill.

R010: Gatimu member moved a motion of amendment to delete figure 303,949,261 (Supply). The figure is deleted. Karau member moves a motion of amendment to insert figure 303.949,260.40 in its place. The figure is inserted and becomes part of the Bill

The leader of the majority moves a motion to insert R011(County Assembly) and Ksh. 482,860,002 amount required for services and expenses. Karau member seconded the amendment and R011 is inserted and becomes part of the Bill.

Sub-totals: Budget Committee chairman Hon. James K. Gachomba (Njabini /Kiburu) move a motion of amendment to delete the Sub Total figure of Ksh.1,534,835,300 (Supply) and 156,247,310 (Appropriation in Aid). The figures are deleted. Karau Member Hon Sammy Douglas Kamau moved a motion of amendment to insert the figure of Ksh.1,534,247,410.00 (Supply- Sub total and 156,247,410.00 (Appropriation in Aid). The figures are inserted and becomes part of the Bill.

Code: Service or Purpose

member for Karau Hon. Kamau moved a motion to insert schedule 2. (Capital Expenditure) He is supported by Gatimu Member Hon Kieru and schedule 2 (capital expenditure) is inserted and become part of the Bill.

D005: The member for Njabini/kiburu Hon. James K. Gachomba moved a motion of amendment to delete figure of Ksh.80,972,00 0 (Supply). He was seconded by Hon.Joshua M. Muriithi (Nyakio). Hon Kamau (Karau) moved a motion to insert figure of Ksh.85,046,000. He was seconded by Kaimbaga member Hon . Samuel K. Njiraini. The figure is inserted and forms part of the Bill.

D011:Hon Peter Mwangi Maina (Central) moved a motion of amendment to insert Code D011 and to read ongoing donor-funded projects of Ksh.284,911,757 (Supply). He was seconded by Karau member Hon. Kamau. D011 is inserted and becomes part of the Bill.

D012: Gatimu member Hon. John Kieru Wambui moved a motion of amendment to insert Code D012 to read County Assembly Capital Expenditure with a supply of Ksh.146,000,000. He is seconded by Karau member Hon. Kamau. Code D012 becomes part of the bill

Subtotals:Gatimu member moved a motion of amendment to delete figures Ksh.2,328,641,644 under Sub Total supply.

He was seconded by Murungaru member Hon Kariuki Muchiri. The figures are deleted and forms part of the Bill.

A further motion of amendment to insert figures of Ksh.2,617,627,399 was moved by Hon Kamau (Karau) and seconded by Hon. Michael N. Kirumba (Kipipiri). The figure was inserted and forms part of the Bill.

Gatimu member moved a motion of amendment to delete the Grand Total figures of Ksh.3,863,476,944 (Supply) and Ksh.156,247,310 (Appropriation in Aid). He was seconded by Magumu member Hon. Peter githinji Ngomba.

A motion to insert figure of Ksh.4,308,710,008.60 (Supply) and 156,247,410(Appropriation in Aid) was moved by Karau member Hon Kamau and seconded by budget committee chairman Hon. James K. Gachomba. The same becomes part of the bill.

Memorandum of Objects and Reasons.

Gatimu member Hon. John Kieru moved a motion of amendment to delete figure of Ksh.3,306,496,255 and was seconded by Hon Gachomba. The figure was deleted.

Hon Kamau also moved a motion of amendment to insert figure Ksh.4,308,710.008.60 and was seconded by Charagita member Hon. Paul Kiruka Mburu. The same is inserted and forms part of the Bill.

The Chairman of committees handed back the chair to the Speaker and comprehensively reported on all the amendments that had been done on the Appropriations Bill .

The speaker then called on the clerk to read the bill a third time. This was done and the Speaker proposed the question that the Appropriation Bill be read a third time.

The chairman of the budget committee Hon James K. Gachomba then move d a motion that the Bill be read a third time. He also made his contributions on the Bill. The Bill was seconded by the leader of Majority Hon. J.M. Gichuki and several other members contributed to the same. All the contributions were in support of the bill.

The Speaker then put the question that the Nyandarua County appropriation Bill, 2013 be read a third time and asked that those in support say “Aye”. The “Ayes” were unanimous and there was no “Nay”.

The Hon Speaker then ruled that the “Ayes” had it and the Bill was read a third time and was passed as law pending assent by His Excellency the Governor.
