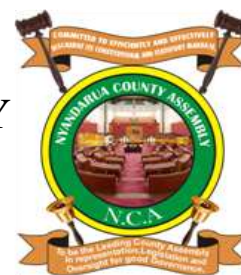

Speaker: The Draft Memorandum of Understanding between the National Housing Corporation and Nyandarua County Government is duly tabled and it stands referred to the Committee on Lands, Housing and Physical Planning. Since Hon. Kariuki Muchiri is a member of the said Committee he could tell this House when the Committee will bring a report on the same in this House.
