STATEMENT

STATUS OF ISSUANCE OF OWNERSHIP DOCUMENTS TO OCCUPANTS OF COLONIAL VILLAGES IN THE COUNTY

(Hon. Paul Ngeche rises on behalf of Hon. Mwangi Maitai)

Hon. Paul Ngeche: Thank you Mr. Speaker. On behalf of my Chair, I hereby seek a Statement from the Chairperson of the Committee on Lands, Housing and Physical Planning on the status of issuance of ownership documents to occupants of colonial villages addressing the following concerns:

Aware that the Constitution of Kenya 2010, under Article 60 provides for the principles of land policy key amongst them equitable access to land and security of land

rights and that Paragraph 8 of Part II of the Fourth Schedule of the Constitution provides for land survey and mapping as a County function;

Further aware that there are several Colonial Villages in the County but majority of the landowners/ occupants lack the requisite land ownership documents;

Concerned that the squatters have been residing in the Colonial Villages for a long time without any title documents;

Further concerned that the lack of title documents have led to poverty and less development for the inhabitants since they cannot make any transactions concerning their land due to lack of land ownership title documents;

Arising from the foregoing, I seek that the Chairperson of the Committee on Lands, Housing and Physical Planning provides the following information;

- i) How many Colonial Villages are there in Nyandarua County?
- ii) The number of households occupying the said colonial villages
- iii) How many colonial villages have been surveyed?
- iv) The status of the title documents for the Colonial Villages; and,
- v) The measures to be taken to ensure that the Colonial Villages are surveyed, mapped and the occupants issued with the title documents in the soonest time possible.

Thank you Mr. Speaker Sir.

Speaker: Chairperson of the Committee on Lands, Housing and Physical Planning, how long would you require to respond?

Hon. Kariuki Muchiri: Mr Speaker, since the Committee on Lands, Housing and Physical Planning is seized of other statement requests, I beg that the Committee be given four weeks to table the statement response.

NYANDARUA COUNTY FINANCE BILL, 2017

(First Reading)

Yes, Member for Kanjuiri Range Ward the Chairperson of the Committee on Finance and Economic Planning, Hon. Suleiman Kimani.

Hon. Suleiman Kimani: Mr Speaker, pursuant to Standing Orders 114 (6) and 123, on behalf of the Leader of Majority, I beg to introduce the Nyandarua County Finance Bill, 2017 for first reading. I beg to table the said Bill. Thank you.

What is it Hon. Githinji Mwaniki?

Hon. Githinji Mwaniki: Mr Speaker, I believe the Bill was tabled unprocedurally. It was supposed to be tabled by the Leader of the Majority party and then committed to the Committee on Finance and Economic Planning. However, the Chairperson of the Committee on Finance and Economic Planning has tabled the Bill and the same has been committed to his committee.
