STATEMENT BY THE LEADER OF MAJORITY

What is it Leader of the Majority party, Hon. Gathungu Kamau?

Hon. Gathungu Kamau: Thank you Mr Speaker sir, I have a statement.

First, let me take this pleasant opportunity to welcome the Hon. Members to the second session of the Second Assembly. It is my hope that members had a happy festive season. Secondly, I thank the members for making the First Session of the Second Assembly a success, for the continued believe, and support to my office. I promise that I will continue to articulate our issues to the best of my knowledge and powers bestowed upon the Majority Leader's office. In this regard, my office remains open and Hon. Members should feel free to contact me in case they have issues that require my attention.

Thirdly, I wish to invite members for an all members *Kamukunji* on Thursday 15th February 2018 at the assembly hall. The aim will be to discuss the matter affecting Hon. Members which shall include among others the content of the report tabled by the House Business Committee on the last day of the previous assembly session.

Lastly, the office has noted with great concern that not all Hon. Members have been supplied with the portrait of H.E the President and H.E the Governor for their ward offices. Concerning this, I wish to request the committee on Members' Welfare, Catering and Library Service to take up the matter and device a way in which members will be supplied with the two portraits and see to it that members with more than two offices get enough portraits for their offices. (Hon. Gathure Wambui rises)

Speaker: What it is member for Kaimbaga?

Hon. Gathure Wambui: Thank you Mr Speaker. Mr Speaker the Leader of Majority has given a speech on his part. I would also like to give a short statement as the 'leader of the independents' and the minorities in this House.

(Laughter)

Speaker: Member for Kaimbaga, please resume your seat. The Leader of Majority had requested for that. The statement by the Leader of Majority and the Leader of Minorities are allowed on Thursdays and I think you are neither of that. There are statements that we welcome, that is, the general statements on Tuesdays but again you will require to give the Speaker a one-hour notice for that statement. However having agreed that we are all on a learning process, I will allow you a few minutes to hear what the 'leader of the independents' wants to say.

Hon. Gathure Wambui: Mr Speaker, you know the Majority Leader is normally given one hour and I can see that he has used about ten minutes. For me I want to take only one minute to touch on some issues.

One is to thank the Hon. Members for cooperating with the 'minorities members' in the assembly. The previous session was successful. However, there are those grey areas where the minority members were left out. I hope that going forward we are going to see cooperation between the members of the Jubilee Party and minority members.

Mr Speaker, we joined this House as opposition but today we are no longer seen as such. As we move on, I might be moving government business in this House Mr Speaker. There is no need for me to elaborate further; you can understand what I mean.

(Hon. Suleiman Kimani rises on a point of order)

Speaker: What is it member for Kanjuiri Range, Hon. Suleiman Kimani?

Hon. Suleiman Kimani: Mr Speaker, I do not know what the member for Kaimbaga means when he says that he is a member from the opposition. The only known opposition in Kenya is NASA. I want to know what he means by saying that he is in the opposition yet I know that he was supporting the president and the government in place today. I need clarification. Thank you.

Speaker: Very well. I would not dwell on that very much. However, I would want to say to the member for Kaimbaga that by the remotest definition of opposition, he could not be one person in the opposition. The constitution defines an independent member as a member who is aligned to neither the government nor the opposition, but is a free thinker, actually an adventurous thinker. Obviously, the member for Kaimbaga knows better than that. He has actually said that severally; that he came to this House for thinking independently. He cannot be the opposition but he can oppose the government position and positions of other independent members, however he will never be defined as opposition because the constitution does not allow him to be such.

Member for Kaimbaga proceed.

Hon. Gathure Wambui: Thank you Mr Speaker, I think I was misunderstood. I meant that some people might have perceived us as not being part of the government. That is not the case because those who perceive us that way are wrong. My friend here could have been arguing it from another perspective but that was on matters of the county. I am the leader of the members in the House elected on an independent ticket but someone out there was saying that the independent members have another leader by the name 'Badilisha'. Mr Speaker, it is notable that the Members elected on an independent ticket are working hand in hand with the government and I will reiterate that these Hon. Members should not see us as outsiders. In the same breath, I would like to thank the Hon. Members for the support they have been giving His Excellency the Governor, just like the President enjoys the support of Jubilee Members both in the Senate and the National Assembly, I would urge Hon. Kimemia....

(Hon. Wambugu King'ori rises on a point of order)

Speaker: What is it Member for North Kinangop, Hon. Edinald Wambugu King'ori? **Hon. Wambugu King'ori:** Mr Speaker, in as much as the Hon. Members are still learning, is it in order for the Member for Gathanji to come into the House inappropriately dressed?

Speaker: The Member for Gathanji should acclimatize himself with the rules of this Hon. House on the mode of dressing. For men, it includes an official* pair of shoes, a pair of socks, a pair of official trousers, a shirt, a tie and a jacket. Member for Gathanji, quietly vacate the House. Proceed Member for Kaimbaga.

Hon.
