*(Clerk-at-the-table confirms that there is no quorum)*

**Speaker:** There being no quorum, I direct that the division bell be rung for the initial ten minutes or until such a time within those ten minutes that the quorum will have been achieved pursuant to Standing Order number 34.

*(The division bell is rung for two minutes)*

*(Quorum is achieved as confirmed by the clerk-at-the-table)*

**Speaker:** Quorum having been achieved let us proceed with the business of the day. First order.

**NOTICE OF MOTION**

**Speaker:** Yes Chairman, Committee on Roads, Public Works and Transport, Hon. Kimani Gachuhi.

*(Hon. Kiruka Mburu rises on behalf of Hon. Kimani Gachuhi)*

**Hon. Kiruka Mburu:** Thank you Mr. Speaker. On behalf of the Chairman of this particular committee, I beg to give notice of the following motion:

That this House does adopt the motion on the Report of Committee on Roads, Public Works and Transport in response to a statement sought by Hon. Dorcas Kihara on management of county machinery as report of this House and the recommendations therein as the resolutions of this House.

*Hon. Michael Kirumba rises on point of order*

**Speaker:** What is it Member for Kipipiri, hon. Michael Kirumba?

**Hon. Michael Kirumba:** Thank you Mr. Speaker. Is it really in order for an honourable member to walk into this House knowing very well that he has a motion yet he is not properly dressed?

**Speaker:** Obviously, the Chairman, Committee on Roads is out of order for the reasons raised by Hon. Kirumba.

*(Hon. Michael Kirumba rises on a point of order)*

**Speaker:** What is it again Member for Kipipiri, hon. Michael Kirumba?

**Hon. Michael Kirumba:** Mr. Speaker, I have also looked around and seen that hon. Kieru Wambui, who is seated just opposite me, is not dressed properly as well. I think it is important that the members appreciate that the Standing Orders must be adhered to.

**Speaker:** Actually, hon. Kirumba you are absolutely right because the dressing code must be adhered to strictly.

*(Hon. Kieru Wambui and hon. Kimani Gachuhi exit the House)*

*(Hon. Kimani Njiraini rises on a point of order)*

**Speaker:** What is it Hon. Njiraini?

**Hon. Kimani Njiraini:** Mr. Speaker, I just wanted to give emphasis on the statement sought by Hon. Dorcas Kihara that the committee should list all the machinery including all the machinery that work within the county and had been inherited from the national government...

*(Hon. Samuel Thuita rises on a point of order)*

**Speaker:** What is it Member for Gathanji? Hon. Njiraini is on a point of order already.

**Hon. Samuel Thuita:** Mr. Speaker, I want to raise a point of order on a point of order.

**Speaker:** Okay, go ahead.
