Assembly Debates

The House Met at 2.30 PM

Hon Speaker in the Chair

Hon Mwangi Gichuki: I want to take this opportunity to bring to the attention of the House and the Honourable Speaker that the House Business Committee did adopt the Senate Calendar in relation to the business of the Assembly and even after adopting the Senate Calendar, the Senate opted to go on recess on the 5th of December. Mr. Speaker due to the quagmire that has been there between the assemblies in Kenya and Salaries and Remuneration Commission, there was need to reopen the assemblies and to close an official matter and this necessitated this Assembly Mr. Speaker to reassemble on the 10th of December.

Mr. Speaker bearing in mind that we had adopted the Senate's Calendar it therefore dictates Mr. Speaker that this Assembly actually adjoin other assemblies, which have actually adopted the Senate's calendar, which requires that we go on recess. Again, Honourable Members we were to have a Kamukuji and I can see most of the members have left and again Honourable Members I have an emergency to attend to immediately. That is why you found I have not responded to the member for Kipipiri because I have to go right away. So I do not know when we will have this matter because we have so many matters pending which cannot wait until 11^{th} February. I would be putting it to the Leader of Majority to work on it between the 20^{th} and 23^{rd} .

I am told we can have a kamukunji on the 20^{th} and start early so that we can deal with it because we will be having interviews that will be going on at the ACK hall. So you can note that you be reporting for training on 15^{th} and the Kamukunji on 20^{th} . The Venue will be the Kenya Institute of Monetary Studies. The arrangements are the same, the way you are facilitated and the training starts on 16^{th} .
