(Procedural Motion on extension of time within which to interrogate the Annual Development Plan for FY 2015/2016)

Mr. Speaker Sir, I beg to move the following Motion:

THAT Pursuant to the provisions of the Public Finance Management Act, 2012, that the County Executive Committee Member responsible for planning shall submit the Annual Development Plan not later than the 1st September in each year, to the County Assembly for its approval;

AWARE THAT the Annual Development Plan, Financial Year 2016/2017 was received from the said County Executive Committee Member on 28th September 2015 and laid on the table on 29th September 2015 and committed to the Budget and Appropriations Committee with directions to interrogate the Paper within fourteen (14) days commencing the 30th day of September 2015;

FURTHER aware that the Committee has been engaged in the public participation of the Nyandarua County Finance Bill, 2015 the House having resolved to extend time for its passage;

THAT owing to this prior engagement, the Committee has not interrogated the Paper within the stipulated timelines which timelines lapse today, the 14th day of October 2015;

I now therefore urge that this House does resolve that:

- i. The time within which to interrogate the Annual Development Plan 2016/2017 be extended by at least twenty-one (21) days; and
