i. Hon. Joyce Ng'ang'a

Mr. Speaker Sir,

I beg to give notice of the following Motion:-

Aware that human dignity, equity, social justice, inclusiveness, equality, human rights, non-discrimination and protection of the marginalized is a key principle of the Constitution of Kenya. Further aware that the law bestows upon the Government the duty to protect and ensure equity and equitable distribution of resources, employment opportunities and provision of disability friendly facilities and services.

Concerned of the graving disparity in the employment of people living with disabilities in the County Government, its entities and agencies. Further

Concerned that no person living with disability has been employed in the county government public service.

Noting that most government as well as privately owned public buildings in the County are not disability friendly for their use.

Now therefore, I urge that this House does resolve that:

1. The County Government through the office of the Governor, the County Public Service Board and the County Assembly Service Board take immediate remedial measures to ensure employment of people living disabilities so qualified for the jobs available.
2. That this house does ensure compliance with the law to have at least 5% of the employment opportunities go to persons living with disabilities.
3. That the Department of Education, Labour and Social Services does come up with a program to ensure the persons living with disabilities are empowered with proper communication means to access county government information and communications. (E.g. availability of government documents and reading materials in braille for blind people.)
4. That the Department of County Public Works ensures that all public buildings and amenities are constructed and upgraded to disability friendly facilities.

Mr. Speaker Sir,

I beg to give notice of the following Motion:-

Aware that the Constitution of Kenya bestows upon the County Government the function relating to promotion and regulation of cultural activities in the county. Further aware of the cultural practice and ceremonies of initiation as a rite of passage in majority of the communities residing in Nyandarua County.

Taking cognizance of the many hurdles and difficulties that the young boys as well as their parents face in finding appropriate and decent initiation training and facilities to undergo this rite of passage.

Noting that majority of the young girls in the County do not undergo the traditional initiation ceremonies that were practiced by the communities living in the County, but still do require proper and well-intended alternative rites of passage.

Further noting that the County government has played no role in these initiation ceremonies for the betterment and well-being of this young section of the County populace.

Now therefore, I urge that this House does resolve that;

1. The County Government through the Department of Education, Labour and Social Services does come up with a program to facilitate and co-ordinate the initiation rites of boys and alternative rites of passage for the girls in the County.
2. The County Government to offer financial, logistical support and engage with the relevant stakeholders (e.g. the Council of elders otherwise known as *Athuri a Kiama* and the Church) in preparing curriculum and programs for the initiation rites of boys and the alternative rite of passage for the girls.

3. That the County Government does undertake to allocate funds for the program in the budgetary provision for the Financial Year 2015/2016.

iii. Hon. David Mwangi Ndirangu

Mr. Speaker Sir,

I beg to give notice of the following Motion:-

Aware that the provision of security services is a critical function of the government to its citizenry. Further aware that the constitution under article 189 of the Constitution encourages the cooperation between national and county governments in execution of their functions.

Concerned of the prevailing crime rate in the county and the lack of adequate security personnel and proper infrastructure in the county to arrest the situation.

Now therefore I urge this house do resolve that the Governor does establish the Nyandarua County Security Program and engagement with the National Government to alleviate the security of the county which among other issues will include the following initiatives:

1. Establishment of County Inspectorate for enforcement of county laws. Get trained personnel in security as well as establish partnerships with Kenya Police Training College and the National Youth Service.
2. Enter into an arrangement with the Judiciary for establishment of County Courts for just enforcement of County Laws.

3. Police presence and response through availability of vehicles – 50 fuelled and maintained security vehicles so that each of our 25 wards will have two police cars- (one for the police and the other for County Inspectorate), and our county will have enough police coverage with a projection to double the fleet in two years' time.
4. Security emergency numbers operational 24 hours - These will be manned using call centers for speedy security and emergency response.
5. Street lighting to enhance visibility – All towns and villages in Nyandarua to have lights installed.
6. Nyandarua Emergency and Security Patrol bases: setting up of emergency centres in towns with emergency bases with a security car, ambulance, fire engine and breakdown vehicle for speedy and effective security and emergency operations.
7. Police Dogs: To enable tracking of criminals, the county should invest in 50 police dogs to be used in all villages and towns to track criminals. Every ward will have a trained Police Dog.
8. Alcohol Blow: To supplement the great work being done by the National Government and to enforce the Alcoholic Drinks Control Act“do not drink and drive law”, to partner with the National Transport and Security Authority for police and enforcement officers in Nyandarua to have adequate alcohol blow devices and speed guns.
