- i. Report on the visit to the State of Israel by a Delegation of the County Government by **Hon. James Mwangi Gichuki**

Noting that the County Assembly did not approve such a programme in the County Budget for the 2014/2015 financial year and yet the same programme was undertaken during the said financial year;

Emphasizing the need for the County Government to be guided and observe the approved budget in undertaking its programmes;

I now therefore urge this Assembly to resolve that the County Treasury does report to the Assembly on how the programme is being undertaken and financed. **Hon. Dorcas Kihara**

- ii. Aware that there is established by an Act of the National Assembly the National Council for Persons with Disability which is accorded various functions including coordinating affairs of Persons with Disability in the Country;

Noting that there is need for the National Council for Persons with Disability to devolve its functions and services in counties particularly to Nyandarua County for effective accessibility of its services;

Further noting that there is established, in the county executive committee, a department dealing with matters of intergovernmental relations to coordinate cooperation between county governments and the national government and its entities;

I now therefore urge this Assembly does resolve that the county department on matters of intergovernmental relations does urgently take necessary steps, to ensure establishment of an office in Ol, Kalou Town, by the National Council for Persons with Disability. **Hon. Joyce Ng'ang'a**
